# Defense-Unique Laws Applicable to the Procurement of Commercial Items and Commercially Available Off-The-Shelf Items

### Requirements for this Report

Section 854 of the National Defense Authorization Act (NDAA) for FY 2016 (Public Law 114-92) requires that the Secretary of Defense submit to the congressional defense committees a report identifying the defense-unique provisions of law that are applicable for procurement of commercial items or commercial off-the-shelf items, both at the prime level and subcontract level. The report requires the Department to (1) discuss the impact of limiting the inclusion of clauses in contracts for commercial items or commercial off-the-shelf items to those that are required to implement law or Executive orders or are determined to be consistent with standard commercial practice and of limiting flow down of clauses in subcontracts for commercial off-the-shelf items to those that are required to implement law or Executive order; and (2) provide a listing of all standard clauses used in Federal Acquisition Regulation Part 12 contracts, including a justification for the inclusion of each. The report is due to the congressional defense committees not later than 180 days after the date of enactment of this Act or on May 23, 2016.

### **Background**

Because of the additional rules arising out of the nature of the Government as a contracting entity, to include socio-economic obligations/goals, the Department is required to protect the public interest while assuring fair treatment to those who deal with the Government. As a result, the Government is required to include terms and conditions in its commercial contracts that would generally not be included in contracts between commercial entities. As part of the Defense Federal Acquisition Regulation Supplement (DFARS) rule making process, the Department published every provision and clause applicable to commercial acquisition for public comments. All comments were considered and dispositioned before the final rule (clause incorporation into the DFARS) was adopted.

### **Discussion**

The attached matrix provides the current list of 85 Department of Defense (DoD) unique requirements applicable to commercial item acquisitions. Of significant importance, the Department is currently in the process of updating the regulations, via a draft DFARS rule, to implement the requirements of sections 851-853 and 855-857 of the FY 2016 NDAA. In the FY 2016 NDAA, Congress provided specific requirements for Commercial item acquisition.

Of the 85 Defense-unique requirements, 24 are provisions applicable to solicitations and the remaining 61 are unique clauses which may apply to commercial acquisitions. Of the 24 solicitation provisions, 16 were required as a result of Statutes, Executive Orders (E.O.) or Standard Commercial Practices (SCP). Of the 61 applicable clauses, 49 are required as result of a statute, E.O., or SCP. The remaining 20 clauses are not the result of statute, E.O., or SCP.

They were included because of the requirement levied to meet the Department's financial accountability obligations, protection of the public interest, or National Interests (e.g., contingency operations). Examples of clauses developed to facilitate the Department's compliance with the Chief Financial Officers Act of 1990 (Public Law 101-575) and the financial reporting requirements imposed by the Federal Accounting Standards Advisory Board were clauses 252.211-7003, Item Unique Identification and Valuation; clause 252.211-7007, Reporting of Government Furnished Property; and clause 252.211-7008, Use of Government-Assigned Serial Numbers. Clauses developed for public interest include clause 252.223-7008, Prohibition of Hexavalent Chromium, which is a known carcinogen; and clause 252.203-7003, Agency Office of the Inspector General, to report violations of Title 18 of U.S. Code or business ethics. An example of a clause developed for National Interests is clause 252.225-7043, Antiterrorism/Force Protection Policy for Defense Contractors Outside the United States, which is required to address the safety concerns of contractors supporting overseas contingencies. The impact of limiting these will reduce the Department's ability to meet its financial accountability obligations, increase our costs and administrative burden, and negatively impact the public safety. The complete list of specific applicable provisions and clauses are listed in the attachment and include the Federal Register notice number, effective date of the clause or provision, whether it was incorporated as a result of statute, E.O., or is considered a SCP, and includes the specific justification for inclusion and any flow down requirements.
