SUBJECT: Acquisition Compliance Scorecard Third Quarter Fiscal Year 2016

This Third Quarter Fiscal Year (FY) 2016 Acquisition Compliance Scorecard features three issue areas: competition, contractor past performance and the DFARS Clause for Safeguarding Covered Defense Information and Cyber Incident Reporting. The metrics are summarized below. We provide these contract scorecards/metrics for your visibility and to improve compliance. These metrics are reported to the Office of Management and Budget as part of the Department of Defense's (DoD) Agency Priority Goal for Reform the Acquisition Process, the Office of Federal Procurement Policy, the Deputy Chief Management Officer as part of the DoD Agency Strategic Plan Fiscal Years 2015-2018 Version 1.0 and the Under Secretary of Defense for Acquisition, Technology and Logistics. The Third Quarter results will be posted on the Defense Procurement Acquisition Policy webpage, <http://www.acq.osd.mil/dpap/>, under "Hot Topics" Scorecards.

Competition Scorecard

Competition remains a recurring agenda item at the Business Senior Integration Group meetings. To increase visibility and ensure your organization's continued contribution to the Department achieving its competition goal, the Third Quarter FY 2016 competition results for the Department and each component are attached. The FY 2016 Department and Component competition goals are listed for comparison. In addition, the competition scorecard provides a comparison of Third Quarter of FY 2016 to Third Quarter of FY 2015. The metrics are derived from the standard competition report using data from Federal Procurement Data System - Next Generation (FPDS-NG) as of July 26, 2016.

Past Performance Scorecard

Timely reporting of quality past performance assessments remains extremely important because the Department's source selection officials rely on this information to make best value source selection decisions. The attached spreadsheet identifies the Past Performance Information Retrieval System compliance metrics as of July 6, 2016, and compares the Second Quarter FY

2016 data of 82.61% against the Third Quarter data of FY 2016 of 84.47% for an increase of 1.86%. I need your continuing efforts to improve our compliance to get us closer towards achieving the Office of Federal Procurement Policy mandated goal of 100%.

Safeguarding Covered Defense Information and Cyber Incident Reporting Scorecard

The threats facing the government's unclassified information have dramatically increased. Recent high-profile incidents involving government information demand that information system security requirements are clearly, effectively, and consistently communicated to both government and industry. DFARS Clause 252.204-7012, Safeguarding Covered Defense Information and Cyber Incident Reporting, requires contractors and subcontractors to provide adequate security to safeguard on any internal contractor information systems that process, store, or transit covered defense information and to rapidly report all cyber incidents to DoD. DFARS Clause 252.204-7012 is prescribed for use in all solicitations and contracts. The attached results for Third Quarter FY 2016 show improvement from 48% to the current compliance rate of 58%. However, this is significantly below last year's 75% compliance rate and we have a long way to go to achieve our goal of 95% compliance.
